(c) Environmental Impact Statement on Use of Target Ship Hulls in Exercises at Sea of August 1971

1. As directed by reference (a), the TRATHEN (DD-530), WICKES (DD-578), HARADEN (DD-585), BELL (DD-587) and BURNS (DD-588) will be stricken from the Naval Vessel Register as of 1 November 1972. They are authorized for disposal pursuant to existing law in a manner most advantageous to the government, and the Chief of Naval Operations was directed to take action incident to their disposal.

- 2. Authority is requested to dispose of these ships as targets to destruction as provided for in reference (b). If this request is approved, these ships are planned for use as test targets in the weapons development program.
- 3. All precautions will be taken to insure against environmental impact. The vessels will be properly prepared for destruction in accordance with reference (c) and the development program will be conducted in the Pacific Missile Range.

1. Reference (a) assigned EX-DDs TRATHEN (530), WICKES (578), HARADEN (585), BELL (587), and BURNS (588) for HARPOON Weapon Systems test program.

- 2. Upon review of the proposals contained in references (b) and (c) and the current heavy schedule of ship inactivations and attendent pier loading at INACTSHIPFAC San Diego, the following exceptions must be stressed.
- INACTSHIPFAC San Diego will assist in the preparation of subject ships as targets at no cost to INACTSHIPFAC San Diego. Approval for the conversion of subject ships will be on a case by case basis as mutually agreed to by the parties involved.
- b. Upon request, custody will be transferred to NAVMISCEN and ships will be returned to INACTSHIPFAC San Diego only if disposal by sale is approved as most advantageous to the government and CO, INACTSHIPFAC San Diego is satisfied that the vessel is in no danger of sinking and is otherwise sea worthy and towable.
- c. All actions involving subject ships such as but not limited to alterations, removals, boarding, etc., will be coordinated with CO INACTSHIPFAC San Diego.
- d. All costs incident to retention of subject ships for HARPOON Test Program will be funded by NAVMISCEN.
- 3. Subject to the provisions enumerated in reference (c) and the foregoing, the proposals of reference (b) are acceptable.
